

### Council Matters January/February 2014

**Bellwood 346 lot DA update** - A DA has now been lodged with Council by the developer, for the construction of the highly controversial 'Link Road' between Alexandra Drive and Marshall Way at Bellwood.

Valla Quarry's Annual Report, lodged with Council in December as required, identified a number of further breaches including an admission that there had been an incursion into the Stage 2 area in breach of conditions which require it to notify Council and prepare a new Environmental Management Plan prior to commencement. Council has not yet decided to impose fines for the breaches, instead deferring the matter to allow the quarry a month to revise its existing EMP to accommodate the 'variances' prior to making a decision. History repeats itself, they say...... Watch this space.

**Further issues with the dam** - leakage problems have now been identified requiring changes to design and construction and further budget adjustments. On a good note, Cr Flack's efforts to have the dam filled as much as possible from rainfall catchment upstream of the dam to reduce massive extraction from the borefield and protect environmental flows, has paid off. Council applied for a licence variation and have now been advised by the Commissioner of the DPI Office of Water that he is prepared to consider a temporary relaxation of the relevant flow licence conditions for 12 months subject to council preparing a Dam Filling Options Report, seeking feedback on the report from relevant State Government agencies and undertaking consultation with downstream landholders.

Following community delegations from residents and representatives of Lock the Nambucca Valley, Crs Flack and Smyth successfully moved to have Council consider a monthly **water testing program** for 12 months from the bottom of North Arm and South Arm, upstream of the Town Water supply, in the next round of Environment Levy projects. The testing program will monitor for common metals (especially arsenic and antimony) and other compounds, with the results providing strong baseline data to protect the Town Water Supply in the event of any pollution from antimony or other mining activities in the upper catchment. Estimated cost \$8,000.

DA 2013/150 Grease Arrestor and Oily Water Treatment Plant Waste Grease Trap Plant on council land by a private operator, at Lot 2 DP 538542, 20 Gumma Road adjacent to Macksville Sewerage Treatment Plant. Previous info was wrong - an EIS has not been prepared so the DA is to be re-exhibited when ALL the information is submitted.

The sale of approx 290 square metres of Gorden Park to a neighbouring private property owner is back on the agenda with Council receiving advice from the Crown Lands Department that as the owner of the land, it now supports the sale proposal which will enable the property owners to erect retaining walls to stabilise the very steep unstable section of Gorden Park immediately below their house. However at the Council meeting the property owner openly admitted that it is most likely they would build out into the new area over Gorden Park to gain more sunlight (not to mention amazing water views). Once again the matter has been deferred with Council requesting that CLD representatives come to a meeting to discuss the highly controversial proposal.

# Map of Life – www.mappinglife.org

Earth is host to an enormous number of species of birds, fish, reptiles, amphibians and mammals, but do you know which animals live where? What critters are you likely to find if you explore the local parklands or even your garden? Map of Life is exactly what it says: an interactive map that tells you the animal life found in your area. Just select the zone radius and the type of animal you're looking for, then zoom in and click where you live on the map (it uses Google maps and so works in the same way). The website presents you with a list of the creatures that live in your area, or you can opt to view tiled thumbnail images instead. Click any critter's name or image and you will be taken to the Wikipedia entry or another information page for that animal.

Public forums are still allowed at the start of each meeting with bookings to made with Council as early as possible. # Video highlights iconic landscapes and communities under threat

The battles to save six iconic wild places in NSW are the subject of a new video that highlights the devastating impact coal mines and coal seam gas projects are having on local communities and iconic landscapes across NSW.

Icons Under Threat is a short film produced by the Nature Conservation Council to raise awareness of the terrible toll the coal and gas industries are having on communities, wildlife, and stunning natural areas in the Hunter Valley and other parts of the state.

The video is comprised of six mini-documentaries focusing on Leard State Forest and the mighty Pilliga in the state's north-west; Ben Bullen on the edge of the Gardens of Stone near Lithgow; the Great Dripping Gorge near Mudgee in the central west; the village of Bulga and Warkworth Sands woodland in the Upper Hunter; and Putty Valley, in the heart of the Wollemi wilderness.

"Icons Under Threat is being launched at a critical stage in many of these campaigns, when the bulldozers and drill rigs are about to move in," said NCC Campaigns Director Kate Smolski.

"It is all too easy for coal and gas companies to do their destructive business out of the public gaze. Icons Under Threat shines a light on this important issue and highlights how the state government is failing to protect communities and the environment from unrestrained coal and gas development."

# Illegal fishing hotline nabs fishy offenders

A tip off from a member of the public to the Department of Primary Industries' (DPI) Fishers Watch Phoneline has resulted in the apprehension of four men and the seizure of 11 Yellowtail Kingfish. Yellowtail Kingfish are a highly valuable recreational and commercial species and are listed as a 'priority' species under the NSW Fisheries Management Act.

#### Land for Wildlife in Nambucca

An opportunity currently exists for Nambucca Valley landholders to join up with the Land for Wildlife Program and enhance the biodiversity of their farm or property.

Nambucca Valley Landcare has received funding from the Catchment Management Authority, through Hastings Landcare, to offer the benefits of this program to landholders in the Nambucca Valley. You don't have to be a member of Landcare to be eligible - schools, public land and parks are eligible to apply.

If you have a minimum of ½ hectare of native vegetation and you would like some support and assistance to improve your wildlife habitat think about applying to join this scheme. Land for Wildlife is entirely voluntary and non-binding and can be integrated into your farming and lifestyle activities. And it is free. You may even want to talk to your neighbours about forming a wildlife corridor.

This program is on offer to a limited number of landholders so the first Expression of Interest (EOI) forms to be received will be assessed first. An Expression of Interest form is the first step and needs to be received by our office by the 7th March.

#### SOMR discovers toxic sediment at Halls Peak

Recently, representatives of the Save Our Macleay River (SOMR) group met with representatives from the Environmental Protection Agency (EPA) and the Derelict Mines Office (DMO) at Gibsons Open Cut, a large abandoned mine on the Chandler River. The meeting came about because of concerns raised by SOMR over "de-sludging" of containment dams.

Gibsons Open Cut in the Halls Peak area is ranked among the top 50 derelict mines causing environmental concern in NSW. Efforts have been made to contain run off from the site. However if contaminated water and sediments leave the site, it all ends up in the Chandler River, which runs into the Macleay.

SOMR's interest had been sparked by reports about recent explorations by Precious MetalResources which could potentially lead to large new mines in the Macleay catchment.

"When we went up there, we saw newly built dams with very brightly coloured water and we noticed that the dams had recently been 'cleaned' by dredging the toxic sediment and dumping it into a gully where it washes into the river", said SOMR chairman Arthur Bain. A site inspection by EPA and DM officers found that a contractor had cleaned out the bottom dams which are designed to catch toxic sediments. Instead of carting the contaminated sludge to a specifically constructed holding area, they dumped it in the bush beside the dam." Soil and water samples were taken and SOMR members were assured that a full investigation would take place. The Derelict Mines Office (DMO) will be investigating and asking questions of the contractor who completed the work. Hopefully this will lead to the problem being fixed as soon as possible – preferably before the next big rain.
